2015 Wisconsin Volleyball Conference State Championships Tournament Format
Friday, April 3 - Saturday, April 4

All Pool Play matches will start at or after the designated start time. Playoff Matches may begin ahead of schedule provided both teams are notified of the earlier start time.

Warm-ups: Pool Rounds 1-2 Friday, 5-6 Saturday and Playoffs: 10 minutes - suggested 3 min ball handling, 6 min shared hitting, 1 min serving
Pool Rounds 3-4 Friday (Playoff option unless first match of the day): 6 minutes - suggested 5 min shared hitting, 1 min serving

All Referees (R1's) are provided for each match. Teams must provide an R2, 2 line judges, and 2 scorekeepers for all pool play and Quarterfinal and Consolation Matches.

The **Men's Varsity Tournament** will consist of the remainder of the regular season double round-robin schedule. These "pool play" games and playoff matches are **best 2 of 3 games to 25**, with game three to 15. No point cap in any games. Game three is played only if it is a deciding game. After pool play, the regular season champion will be determined, and all teams will then be pre-seeded into the Championship Division Quarterfinals based on their regular season (pool play) finish. Quarterfinals winners will advance to the VARSITY MEN'S CHAMPIONSHIP SEMIFINALS while the Quarterfinals losers will advance to the VARSITY MEN'S CONSOLATION SEMIFINALS. Losing teams in the consolation semifinal rounds will officiate the next match on their court. The VARSITY MEN'S STATE CHAMPIONSHIP MATCH will be played at **5:00 pm** on CHAMPIONSHIP COURT.

After the completion of Pool Play, all teams in the **MEN'S VARSITY DIVISION** will be **seeded** into the Championship Playoffs based on:

- (a) Overall Season Match Record
- (b) Head to Head Match Record
- (c) Game Percentage (games won/total games played)
- (d) Point Percentage (points scored/points opponents scored)
- (e) Coin Flip

The **Women's Varsity Tournament** will consist of two 4-team pools and one 3-team pool and will play standard Pool Play format against teams in your pool, with the exception of Pool C in which teams will play **two** matches against each team. All pool play and playoff matches are **best 2 of 3 games to 25**, with game three to 15. No point cap in any games. Game three is played only if it is a deciding game. After the completion of Pool Play, the top two teams in each pool will advance to the WOMEN'S CHAMPIONSHIP PLAYOFFS while the third and fourth place teams in each pool will advance to the WOMEN'S CONSOLATION PLAYOFFS. Losing teams in the semifinal rounds will officiate the next match on their court. The WOMEN'S STATE CHAMPIONSHIP MATCH will be played at **3:00 pm** on CHAMPIONSHIP COURT prior to the **Men's JV State Championship Match**.

- (b) Game Percentage (games won/total games played)
- (c) Point Percentage (points scored/points opponents scored)
- (d) Coin Flip

The **JV Women's Tournament** will consist of 2 5-team pools and will play standard Pool Play format against teams your own pool. All pool play and playoff matches are **best 2 of 3 games to 25**, with game three to 15. No point cap in any games. Game three is played only if it is a deciding game. The top three teams in each pool will advance to the **WOMEN'S JV CHAMPIONSHIP PLAYOFFS** while the third and fourth place teams in each pool will advance to the **WOMEN'S JV CONSOLATION PLAYOFFS**. Losing teams in the consolation semifinal rounds will officiate the next match on their court. The **JV WOMEN'S STATE CHAMPIONSHIP MATCH** will be played at **2:00 pm** on **CHAMPIONSHIP COURT** prior to the **Women's Varsity State Championship Match**.
